

## EMBRACING LIFE: YOGA, WELLNESS, AND TRAVEL RETREAT CANCELLATION POLICY

Our cancellation policy is in force to institute policies that protect the sustainability of this retreat. We will not amend our policy under any circumstances, so we strongly recommend purchasing travel insurance to protect your investment.

Please read our cancellation policy and sign and write your name at the bottom of this agreement, which will be your signature in accordance with this policy.

### **Janette Inda and Theratea yoga cancellation policy:**

1. To secure your place in the retreat, a deposit of \$500 of the value (non-refundable) is required, which must be made within 7 days after you have received your registration form. In case of cancellation this deposit will not be refundable or transferable, WITHOUT EXCEPTIONS.
2. If you opted to reserve a double or triple room, you will be responsible for securing your own roommate. In the case that your roommate/s cancel, you will be responsible for 75% of the full cost of a single or double accommodation, allowing you to have the room to yourself, with a 25% discount of the regular price.
3. If you choose to cancel your place in the retreat, you must write your reasons in an email addressed to: [therabeyoga@gmail.com](mailto:therabeyoga@gmail.com) or [jaguzmanyoga@gmail.com](mailto:jaguzmanyoga@gmail.com)
4. The total amount of your retreat investment must be paid in full no later than March 22nd, 2026.
5. If the cancellation occurs before January 21st, 2026, \$500 will be retained and non-refundable, the rest of your investment will be refunded or credited for future events or services.
6. If the cancellation of this retreat occurs after January 21st, 2026, the full amount of your investment will not be refunded or transferable for other events or services.
7. In case that Janette Inda (facilitator of this retreat) cancels this retreat due to uncontrollable circumstances, the full amount of your retreat will be refunded. However, prior to such cancellation, alternate retreat options will be explored and proposed to you. Janette Inda and theratea yoga are not responsible for your expenses incurred in preparation for any canceled retreat. This may include airline tickets, time off from work, or other expenses associated with preparing for this trip/retreat. Therabe yoga and Janette Inda strongly encourage you to purchase a trip insurance that covers any medical or trip cancellation expenses made during your retreat.. Therabe Yoga or Janette Inda will not be responsible for any participation in the purchase or any arrangement regarding this retreat. In the event that Janette Inda cannot facilitate this retreat, she will be substituted by another facilitator and this fact will not be a reason for reimbursement, since the retreat is still taking place. If the participant decides to cancel, the agreements already mentioned in this policy will be respected.
8. In the event that a covid-related travel ban occurs during the dates of the retreat, and you show a positive PCR test, you will receive a credit valid for 12 months, which can only be issued to receive private/group yoga lessons, or special events. This will not be a reason for reimbursement.
9. Only one cancellation/reschedule per reservation will be allowed. A second cancellation/reschedule will result in the forfeiture of all funds paid for this retreat.
10. Therabe will not be responsible for any acts of God.
